"THE UNWANTED CHILD"

A Wonderful Play Coming to Marion

Club women in all parts of the country are interesting themselves in unwanted babies and trying to solve a problem that they believe should have been solved long ago.

Whatever feelings may have been expressed in the past toward the unwanted child, there is no question of the changed sentiment of today, due to the efforts of noble hearted men and women who have studied conditions with special reference to the effects of this evil. A social phenomenon, hitherto left to writers of fiction to portray in all its sadness, is now being inquired into by liberal minds and presented in a new light.

One of the strongest pleas for sympathy for the innocent child is made in the drama "The Unwanted Child" which comes to the Court House Auditorium for one night, Tuesday, March 10th. Total number of Instructive visits to Pre-school children 17. Total Business visits 18. Total number of Schools visited 5. Grand total number of visits 184. Arrangements have been made with doctors in Bristol to conduct eye clinics for school children, this work will be started the first of March. One class in Home Hygiene and care of the sick has been organized in River Side School. 16 High School girls have enrolled. Classes will be conducted twice a week until the course is finished. Preparatory work has been started for the Tuberculosis clinics which will be held for the benefit of Smyth County people in Marion, March 11th and Chilhowie, March 12th. After checking up with the school work that has been done since September the following report is made: Total number of children inspected 4542. Total number of class rooms visited 156. Total number of children with defective teeth 1237. Total number of children with defective tonsils 982. Total number of children with defective eyes 476. Total number of children with defective hearing 111. Total number of children with symptoms of mouth breathing 492. Total number of children in Smyth County with out defects 974. Total number of schools visited 78. Total number of children checked up 1931. From 4542 children inspected 1931 have been checked over, leaving 2611 children still to be checked up and determine the kind of defects.

"LADY OF THE ROSES," DIES IN HOME HERE

Mrs. Sophie Kremer Kernan, 91 years old, widely known as "The Lady of the Roses," died yesterday in her home, 1201 Peery street north-east. Mrs. Kernan's roses were known far and wide, and Mrs. Edith Galt Wilson was wont to motor out to view them and to take a few home to the stricken former President in his last illness. Mrs. Kernan's picture was published as the cover page of The Post's rotogravure on last Mother's Day. On her ninetieth birthday she received a personal letter of congratulation from the Pope.

Mrs. Kernan was a native of Winston-Salem, N. C., where she was born August 4, 1833. She was educated in the Salem Female academy, now Winston-Salem Women's college, and married Dr. Thomas Dickinson Kernan. Her husband attended Gen. Stonewall Jackson in his last illness. As a widow she came to Washington sixteen years ago.

Funeral services probably will be held tomorrow morning from St. Patrick's Catholic church.

Mrs. Kernan is survived by a sister, Mrs. S. K. Stevenson, of Winston-Salem; two sons, Dr. Charles Kernan, of Pulaski, Va., and Dr. Paul Kernan, a daughter, Miss Julia Kernan, of Hartford, Conn., and two grandchildren, Miss Julia Kernan, of Brookland; and Thomas D. Kernan, of New York—Washington Herald.

THE PRESIDENT'S NEW CABINET.

These are the men President Coolidge has chosen to sit in his cabinet under the new administration which begins March 4th.

Frank B. Kellogg of Minnesota, Secretary of State. Lawyer. Age 68. Native of Potsdam, N. Y. Served Department of justice under Roosevelt and Taft as trustbustler, and Interstate Commerce Commission as special counsel. Senator from Minnesota 1917 to 1923. Ambassador to Great Britain since December, 1923.

Andrew W. Mellon of Pennsylvania, Secretary of the Treasury. Financier. Age 69. Native of Pittsburgh, Pa. Member of one of the country's wealthiest families with many banking and industrial connections prior to his appointment to the cabinet in 1921. Founder of town of Donora, Pa., and steel mills there.

John W. Weeks, of Massachusetts, Secretary of War. Banker and broker. Age 64. Native of Lanchester, N. H. Graduated Annapolis Naval Academy and served two years as naval officer. Member House of Representatives from Massachusetts 1905 to 1913. Senator from Massachusetts 1913 to 1919. Became Secretary of War March 4, 1921.

Charles B. Warren of Michigan, Attorney General. Lawyer and business man. Age 54. Native of Bay City, Mich. Over period of years served as counsel for United States in various international litigations. Long a leader of Republican party. Ambassador to Japan, 1921 to 1923. Ambassador to Mexico February, 1924, to August, 1924. A contest has arisen in the Senate over his confirmation.

Harry S. New of Indiana, Postmaster General. Publisher. Age 66. Native of Indianapolis, Ind. Was reporter, editor and part owner Indianapolis Journal before he entered public life. Republican National Chairman 1907 to 1908. Senator from Indiana 1916 to 1923. Became Postmaster General March 5, 1923.

Curtis D. Wilbur, of California, Secretary of the Navy. Lawyer and jurist. Age 57. Native of Boonesboro, Iowa. Graduate Annapolis Naval Academy. Taught school, practiced law and served in various capacities as prosecutor and judge at Los Angeles. Elected Chief Justice California Supreme Court, 1922, and resigned March 19, 1924, to enter cabinet.

Hubert Work, of Colorado, Secretary of the Interior. Physician. Age 64. Native of Indiana, County, Pa. Gained wide reputation as practicing physician at Greeley, Col., and was President American Medical Association 1921 to 1922. Active in Colorado politics for years. Served in medical corps in World War. Assistant Postmaster General 1921 to 1923, and Secretary Interior since then.

William M. Jardine of Kansas, Secretary of Agriculture. Grain expert and college president. Age 46. Native of Oneida County, Idaho. Was a cowpuncher in Idaho and Montana before entering college. Served in agriculture department as cerealist 1907 to 1910, and on faculty Agricultural College of Utah and Kansas State Agricultural College. President latter institution since 1918.

Herbert C. Hoover, of California, Secretary of Commerce. Mining and industrial engineer. Age 50. Native of West Branch, Iowa. Won international fame by his services for Belgian relief in early days of World War. Later was wartime Food Administrator, and head American Relief Administration, United States Grain Corporation, and Sugar Equalization Board. Became Secretary of Commerce March 4, 1921.

James J. Davis of Pennsylvania, Secretary of Labor. Steel worker and fraternal organizer. Age 51. Native of Tredegar, Wales. Came to America at age of eight. Worked as iron puddler in Pennsylvania.

Report of 1924 Christmas Seal Sale in Smyth County, county people being benefited.

Marion received from her \$194.42 sale	145.81
Chilhowie received from her \$60.00 sale	45.00

Other parts of county from \$94.85 sale	71.15

Total per cent for county \$298.40
The total 75% \$298.40 must be used this year for Tuberculosis work. The towns usually decide the way they use their money. The county's \$71.15, which is in charge of the Treasurer is being used for the benefit of county patients. In places where only a few seals were sold it

is not practical to send the small per cent to them, so it is kept in a lump sum.

This year 1925 the Marion Tuberculosis Organization has paid \$28.00 board at Catawba for a Rich Valley tuberculosis patient, and will pay \$10.00 a month for three months for another county patient.

In 1924 board, amounting to \$126.00 was paid for two county patients—one at Catawba, the other at Blue Ridge.

In 1923 board amounting to \$55.00 was paid for a county patient at Catawba Sanatorium. To show how much interest the school children in Marion took in the last seal sale, I shall re-publish the amounts—Marion High School \$7.76, Grammar School \$14.95, Colored School \$10.00, total \$32.71.

The Marion Tuberculosis Committee gave \$9.09 for postage and other expenses for the success of the 1924 Christmas Seal Sale.
