Congressman Upshaw Speaks to Large Crowd At Baptist Church.

Congressman W. D. Upshaw, of Georgia, paid Marion a visit Wednesday making three fine addresses. He visited the Marion Grammar School and Marion High School in the morning delivering an address at the opening exercises at each place, afterwards going to Marion College, where he delivered a very stirring appeal for the advancement and future development of better citizens and with the appeal to hold firm to the principles for good government and for the principles supported by the Anti-Saloon League.

In his speech during the evening he recited several instances showing the sacrifice that lots of the supporters of the league were making in the interest of the work and for the success of the league.

He compared the results of the work of the league with the results of those organizations opposed to it and told how the European nations were eagerly watching the results of Prohibition in America. All four addresses made in Marion were of the highest order, full of wit, advice and inspiration were received with delight by all who had the pleasure of hearing the Congressman speak.

AN OUTRAGEOUS BALLOT.

Not alone in the Coolidge landslide was yesterday's election a revelation, for many Virginia women learned for the first time how difficult it is to vote in this commonwealth. It might almost be said that voting has become a highly technical procedure which was designed to prevent and not to record the expression of public opinion. The purpose of preventing a free expression of the public will has been most admirably accomplished and the gentlemen of the constitutional convention, who planned the present electoral qualifications of Virginia, can take just pride in viewing the success with which their legislative barriers have deterred many and repelled as many more from the exercise of the right and duty of voting.

Innumerable citizens, who had with no small expense of time and trouble sought to qualify for the privilege of voting, found themselves disqualified by the intricate and vexatious regulations thrown around the ballot box. Many others were disqualified by the carelessness with which their names and tax payments were recorded.

But of all the snares for the simple minded voter the ballot itself appeared to be the most deadly and the most effective. In one precinct in Richmond, in a ward where education is unusually high, over one-third of all the ballots were thrown out for being improperly marked. Such a situation is an outrage on the voter. When a citizen pays his taxes and goes through the arduous and complicated process of qualification for voting, the ballot at least ought to be foolproof. As a matter of fact, the ballot is proof that it is designed to deceive the wise, and not to safeguard the foolish.

Are Virginians so imbecile that they cannot be trusted to express their own opinion at the polls? Or does the constitution feel that the opinion of Virginia is not worth recording? Evidently one of the two thoughts controlled the framing of the present constitution. Equally plain is it that Virginia cannot have at the same time an extremely difficult method of voting and a free expression of the voters' will. In a democracy it is essential that voting be simplified to the last degree. By this test Virginians may be Democrats, but Virginia is not a democracy.—Richmond News Leader.

If a republican had written the above editorial partizan democrats would have replied, "nothing in it" only the same old cry our opponents have been making since the present constitution was promulgated and rammed down the throats of the people.

This editorial, as it comes from the hand of the ablest democratic editor in the state, is really heartening. Will it tend to arouse the dormant mind of the machine which holds the political destiny of Virginia in its hands? We wish the editorial could be read by every voter in the state, especially every woman voter. "The situation is an outrage on the voter." "Are Virginians so imbecile that they cannot be trusted to express their own opinion at the polls." "Virginia is not a democracy." These are strong statements but they come from the pen of a leading democrat who feels outraged because the evils which he is striking at, is sapping the very political life from old Virginia, and for no purpose, except to promote fraud and corruption and continue a political oligarchy in power in the old state.

May the News Leader keep up the fight until the heart of old Virginia is aroused and the people of the east will rise up in their power and join hands with the Southwest to break the shackles which bind us. This outrageous ballot caused more than 200 voters in Smyth County to lose their votes.

The Marion Public Library

Away back yonder in prehistoric times when motor-cars and movies were little more than dreamy possibilities, when card parties were taboo when social entertaining was limited to family dinners and the Tea Club when the only public organizations worthy of mention were the Odd Fellows and the Missionary Societies, the Marion Library Association was formed.

In those days people had plenty of time to read, so this step towards civic betterment was enthusiastically received. The Marion Public Library soon became an important factor in our municipal life, and for several years enjoyed a generous patronage. With the astonishing change in the times, however, and the advent of new pleasures and pursuits, interest in the library began to wane, its clientele falling off so rapidly that it became difficult for the association to maintain it on the small fund which found its way into the treasury. Instead of growing with the town, the library seemed to follow a sort of inverse ratio.

About twelve months ago, Miss Florence Fell, who for several years had given faithful and efficient ser-

vice, tendered her resignation, which was reluctantly accepted. The library then "shut down", to the distress of the few who had continued their patronage, and to the everlasting disgrace of one of the wealthiest and most up-to-date of the smaller towns of Virginia.

Feeling that a public library is a valuable asset to a town, and that the town of Marion is amply able to support such an enterprise, the Marion Book Club rallied to its aid, and since February first has endeavored in the face of considerable discouragement to awaken the interest of the public. These young women gave generously of their time, strength and money to the re-establishment of the library, working untiringly for many days in its behalf, their work consisting in cataloguing the books, sorting out the undesirable or dilapidated volumes, re-numbering them, moving them from their old quarters into the Woman's Rest Room in the Court House, and arranging them attractively in alphabetical order. Moreover, each member of the Club donated a new book to the collection, and will make this donation each year that the library is under their control.

The Book Club has received no material return for its labor and its gifts, and expected to receive none, nor does any member of this club anticipate any material benefit from an increase of library patronage. Every cent which goes into the treas-

ury is devoted to the purchase of new books, and to other necessary expenses of the undertaking. In taking charge of the library when its state seemed hopeless, the Book Club has performed a noble service, and one which the public should appreciate.

We Marionites are rather inclined to boast of the fact that Marion is rapidly forging ahead of other towns in this section, and perhaps this is true. Yet many of these other towns maintain flourishing public libraries, some of which are free to the reading public. Wytheville's public library is the pride of her civic life, and receives the enthusiastic endorsement of her people. Why permit our sister-towns to surpass us in any respect?

To those of us who are interested, it would seem that not only the town people, but the county people also, would appreciate and welcome such an institution as a public library, especially one which is open from three to five on Saturday afternoon, the day when the county people are most apt to be in town. At the cost of only a few pennies and a few extra steps, our county-friends can secure one or more entertaining books which will help them to while away their quiet winter evenings. The same welcome which is awaiting them will be extended to the teachers, and students of Marion College, the teachers and students of the Public Schools, to the various members of the great family at the Southwestern State Hospital, and to all strangers within our gates who crave the luxury of a good book at nominal expense.

A year's subscription, which will cost you one dollar, entitles you to one book a week. Books can be kept out for two weeks. If kept out longer a fine of ten cents will be charged for each successive week. Books can be rented at five cents each for one week, or two. Neither subscribers nor renters are permitted to exchange books after they leave the library, nor to lend books outside of their own homes. Books cannot be rented on credit. When books are kept out over two weeks, no other book can be taken from the library until all fines are paid and all books returned. Subscribers and renters will be held responsible for loss or serious damage while books are in their possession. Books must not be returned to the library except during the hours mentioned above.

The librarian will be glad to advise you in the selection of books, or you are at liberty to make your own selection without interference if you prefer.

Miss Thelma Riddle of Atkins entertained her pupils Friday night with a Halloween social. Prizes were won from the usual Halloween games by Lucile Pickle, Frank Musser, Lewis Musser, Clyde Hash and Garland Doyle. The witch made herself very entertaining. The children did not appear to be the only ones who were enjoying the occasion.



RED CROSS DUTY TO AID VETERANS

Spends Nearly Four Millions in Year to Lessen Burdens of Disabled Soldiers.

SERVES 63,700 IN HOSPITALS

Every Case Is Given Individual Service—Assists Families of These Men Everywhere.

Washington.—The need of individual assistance by ex-service men and their families from the Red Cross is as pressing today as it was immediately after the end of the World War. For six years this work has been foremost of all Red Cross services, and in emphasizing the steady public support of this work the Red Cross National Headquarters urges the largest enrollment this year during the membership campaign opening on Armistice Day, November 11.

Nearly four million dollars of Red Cross funds spent for disabled veterans and their dependents during the year ended June 30 last presents some idea of the magnitude of this work. The current year, it is estimated, will call for still further disbursements of funds for the reason that the Red Cross, through more than 3,500 Chapters in as many communities in the United States, has been called upon to help the ex-service men in making out their applications for the adjusted compensation granted in the so-called bonus law.

58,767 Solder Cases a Month
The Red Cross work for the disabled soldier is designated "home service," for it gives individual attention to the man and his family approximating the interest and loving care of the home. Such service in the hospitals, camps, soldiers' homes and sanatoria, averaged 33,951 cases a month during the year. Assistance to ex-service men and their dependents averaged 58,767 cases a month. In addition, the Red Cross in the last twelve months provided 33,000 recreation and entertainment events in the hospitals and camps.

Thus the Red Cross, symbolized as the "Greatest Mother," still watches over these many thousands of men, comforts them, helps to lighten the tedium of their physical reconstruction, and in their homes lifts some of the burdens from their "own people."

Work in Communities Increases
The home service of the Red Cross was the most pressing duty of 2,569 Chapters, an increase of 182 communities where problems affected by the war veteran's condition required solution through immediate and intelligent assistance. The Chapters alone expended some \$2,000,000 in this work.

The transient disabled soldier, usually suffering from disability or tuberculosis, is almost everywhere a grave problem. From national funds the past year \$173,076.36 was expended in helping the Chapters to care for these wandering men.

According to government report there are 4,800 veterans in civilian institutions, and in the national homes for soldiers the complications are increasing. The large groups of patients whose claims have been disallowed, or veterans of foreign wars, and the great number of men permanently residing in these institutions call for Red Cross work which cannot be avoided nor denied.

Definite Service to 73,700

Of a total of 84,500 ex-service men in hospitals and other institutions 73,700 were rendered a definite and specialized service by the Red Cross. In a single month 4,185 new cases were presented and a total of 20,125 was acted upon—figures which serve to illustrate the magnitude of the information and claims service engaging the attention of Red Cross workers. New veteran legislation amending the War Risk act which extends many additional rights to disabled ex-service men will reopen thousands of cases and require still greater Red Cross service.

When Congress granted a charter to the American Red Cross it charged the organization with the duty to act as "the medium of communication between the American people and their Army and Navy." This responsibility to the enlisted men and their families is met every year without restriction. Serves Men on Active Service

The extent of this Red Cross activity during the last year embraced a total of 195,246 cases. There were 35,995 separate soldiers' and sailors' claims; 20,316 investigations of home conditions; 14,421 cases related to discharges, furloughs, etc. Assistance was given in 39,688 instances for personal, business or family problems; 744,220 visits were made to the sick or disabled, and nearly 40,000 letters and telegrams dispatched to the homes of enlisted men.

From June to September at the numerous military training camps the Red Cross provided information and home service to the trainees, also instruction in First Aid and Life-Saving. The entertainment and recreation events at the various Army and Navy hospitals reached nearly 8,500 during the year, and occupational therapy in nine Naval hospitals gave constructive and beneficial results and occupied the time of patients in the making of useful and ornamental things.



Christmas Seals.

This year the Virginia Tuberculosis Association has conducted a series of conferences on the Christmas Seal Sale at different points in the State. Dr. Wm. M. Smith, Executive Secretary, Miss Leslie C. Foster, Assistant Secretary and Miss Rita Izard, Field Worker, have conducted these meetings, which to date have been held at Norfolk, Danville, Lynchburg, Roanoke and Bristol. Others scheduled are to be in Charlottesville, Alexandria, Harrisonburg and Fredericksburg. The Chairman from the group of counties accessible to these points are asked to attend the meetings, where the plans for the coming sale are outlined and methods of selling and advertising are discussed.

Already arrangements have been completed for the Seal Sale in most of the counties of Virginia, and also the cities, and organizations will be perfected in the remaining ones very shortly. Because of the fact that organization for the sale is nearly complete so early it is hoped that the sale will be unusually large this year.

Seventeen Million Christmas seals are being distributed in Virginia through the branches of the Virginia Tuberculosis Association. The 1924 seal shows a woman's figure, representing knowledge, holding aloft a flaming torch, while she rests upon the shield of the double barred cross, which is the emblem of the fight against tuberculosis. The seal which was designed by a well known artist, is unusually rich in coloring.

Some Election Anomolies.

The election last Tuesday showed some sharp anomalies. Smith was elected governor in New York while Coolidge carried the state by over 800,000 majority.

Coolidge carried Ohio by about half a million and Donahay. Democrat was elected governor. Mrs. Nellie Ross was elected as Democratic governor of the Republican state of Wyoming.

Unless later returns change the result Brookhart is beaten for senator in Iowa by a Democrat and Magnus Johnson by a Republican in Minnesota.

At Home and Abroad.

AN INTERESTING ACCOUNT OF
THE THOMAS TOUR THROUGH
THE UNITED STATES AND
CANADA

By Z. V. Sherrill.

(ARTICLE SEVEN)

Apolinaris Spring is on the east side of the highway not far from the ten mile post, a natural Apolinaris water, an exact reproduction of the article of commerce.

Absidian Cliff is twelve miles south of Mammoth Springs, this was the neutral grounds to all the Rocky Mountain Indians tribes.

There is a kind of glass here or volcanic origin. Chips of this and specimens of partly finished arrow heads of obsidian are found throughout the park. Next we come to Roaring Mountain and there are countless openings in its side from which can be seen steam coming from these openings. The sound produced now is much less than formerly.

Twin Lakes four miles from Norris are remarkable for the different colorings although they are in close proximity.

Norris Geyser Basin is our next short stop. Congress Pool is the first object of interest. This is an immense boiling spring close to the road. Formerly this was very noisy and could be heard miles away. In the winter of 1898 the 'Steam Vent' ceased and the Congress Pool takes its place. There is a board walk across the Norris Geyser Basin, and to the left of this walk is first the Opal Springs, the Iris Pool and the Grindstone all boiling pools of hot water. The Constant Geyser is 24 feet across. Every 30 seconds are displays of this remarkable geyser. Then we come to the Whirligig, then the Mud Geyser. The Black Growler Vent roars constantly and great volumes of steam come from its throat. This displays are irregular some seasons being much more violent than others.

The Hurricane is not so violent. East of the roadway is the Bath Tub. It does not erupt, but is continually agitated.

There are several others named Emerald Pool, New Crater Geyser, Monarch Geyser, Fearless Geyser, Minute Man Geyser, Chocolate Spring and others. Three miles from Norris Basin the road enters Elk Park, a beautiful valley, surrounded by heavily timbered hills.

Our road now enters Gibbon Canyon on the east side of the river, and this river we follow for several miles with high precipitous cliffs on one side in places a thousand feet high. Beryl Springs is the largest boiling spring in the Gibbon Canyon. It is 15 feet across and is close by the road-side.

Gibbon Falls is next seen 80 feet in height. The National Park Mountains are at the junction of the Gibbon and Firehole rivers. Here we arrive at the junction of our route coming into the park and now we travel toward our entrance at Yellowstone Station at West Yellowstone.

We arrive just in time for our dinner of boiled speckled trout of the six inch type before boarding our train for Salt Lake City. Resume we have spent three days and two nights in the Park and traveled about 125 miles by Auto Busses, besides the many tramps we have had. We spent two nights, one at Old Faithful and the other at Yellowstone Lake Hotels, we had dinner at the Canyon and luncheon at the Mammoth Hotels. We did not have time for side trips over the trails either by horse-back or by tramps, but we had a delightful trip and enjoyed every minute of the time we spent in our nations great playground and every one seemed happy and contented with all we had seen.

The four and a half days tour is \$45.00 and the five and a half days is \$77.00.

Yellowstone Park has no fence around it as some might suppose, but it is the largest and best game preserve in North America. Its climate is suited to the habits of a very large number and species of animals and they are preserved in their natural state from molestation of the hunter.

All animals in this preserve are never molested except the Mountain Lion and the Coyote, both of which are very harmful to the young of other animals especially of the Mountain Sheep, Elk, Deer and Antelope. All hunters and poachers are rigidly excluded and in winter when it is sometimes hard to secure forage these animals are fed especially the Elk and Antelope. There are in reality hundreds of animals in this park. Some of which I mention, the Grizzly Bear, the American Black Bear, the Buffalo the Pronged-horn Antelope, Mountain Sheep, the American Elk, the Moose, the Puma or Mountain Lion, Bobcats and Lynxes in small numbers, the Timber Wolf in limited number, Coyotes. These animals are shot on sight by the Rangers who live in the park. They are said to be plentiful in the lower altitude of the park, whereas the Mountain Lion takes to the higher altitudes. The Otter, the mink, the

common Weasel, the Marten, the Wolverine the common Skunk, the Badger, the Beaver, Woodchuck or Groundhog. I think I have forgotten to say that Deer are in abundance some of which we saw. There is a large variety of birds in the park, but not many of a kind are found. The Eagle, Osprey, Sea-Gull, Pelican, Goose, Swan, Crane, Crow, Raven, Magpie, Blackbird, Robin, Grouse, Jay and a very large variety of ducks. Wild ducks and geese are often seen by the road side. The Lakes of the park are inhabited by numerous water fowl. Pelicans and Gull occupy an entire island in Yellowstone Lake.

The Canadian Geese rear the young here in great numbers and are quite tame. None of the streams of the Yellowstone had any fish in them except the Yellowstone River and Lake.

They were stocked by the U. S. Bureau of Fisheries. Some time in 1889 the streams were stocked and since this time there has been an abundance of fish. In 1924 the government established a hatchery on Yellowstone Lake.

The plateau is fringed with cataraacts which no fish can ascend to the very best of trout streams were naturally left destitute of their natural inhabitants, although the streams are among the coldest in the Rocky Mountains and therefore well adapted to trout as has been proven. Besides the various kind of trout the Grayling and White fish are also found. All fishing in the park is limited to the ordinary hook and line method any fish under 8 inch must be returned to the waters.

About four-fifths of the park is under timber. This timber is of little commercial value, most of it being too small, even if the government would permit the cutting of it. Its importance consists in the fact that it is head-water or flood-water for our great river systems.

As I have already said the continental divide runs through the park and the waters feeding the Snake River, the largest tributary of the Columbia on the Pacific side and on the east are the principal water shed for the great Missouri River.

These forests are acting as a check valve on floods, preventing the rapid melting of snows in the spring and the large amount of leaves and decaying wood makes a spongy soil that absorbs rain and snow water thus allowing the waters to trickle out slowly. It is therefore of great importance generally to our country to preserve these forests as well as many others in the U. S. About three fourths of all the trees are Lodge pole known as black pine. This is the predominating growth in the park plateau the trees are slim and bear branches only near the top.

These logs are valuable for the log cabins many of which are found in the park. The Douglass Spruce is next in importance, also the Engelman Spruce. These are found mostly in the ravines because they require more moisture for growth. They are characterized by their cones.

The Fir or Balsam is found here. Two species of Juniper. The narrow leaved Cottonwood is found near the Gardiner entrance. The Aspen or Quaking Asp a member of the popular family is rather abundant. The flowers are numerous. In places in the park the bloom almost obscures the green leaves of the flowers. The flowers while so numerous yet they are in the main small. The Rock Rose and Bitter-root the Pasque Flower the Water Leaf, the Lung-worth, Phlox, Dog Tooth Violets and many others. The Larkspur, Wax-Flax, Harebell, the False Snapdragon etc.

We were informed that about 500 Auto Buses were in use to accommodate the many visitors to the park. The park season opens June 20th, and closes September 15th. I saw somewhere that the speed of Autos was limited to 12 miles. There seems to be no observance of the Sabbath day as we saw men and teams busily engaged in road building, freight being hauled and many other kinds of labor. Our driver didn't seem to know that we were traveling on Sunday until informed by some of our party.

Yet protestant preaching and worship is conducted every Sunday at a chapel at Mammoth also Catholic worship occasionally.

I might mention many other facts concerning this great playground of our great U. S. but must pass on now and directly board the train at Yellowstone. From this point I hope to proceed next week.
