## At Home and Abroad.

AN INTERESTING ACCOUNT OF THE THOMAS TOUR THROUGH THE UNITED STATES AND CANADA

(Article Three.)

Arrived at Vancouver, B. C. 9:20 P. M. Pacific time. August 5th, 24. Seven days since leaving Marion, Va.

Here we left the party at the Terminal Station of the C. P. Ry., climbing two long flights of steps and walking over on an elevation that crossed a number of R. R. tracks we came directly to our big steamer, the "Princes" that was to carry us down the Puget Sound to Seattle. We boarded the steamer, securing a state-room and were soon moving down the Sound. It was a very nice change too. The steamers are clean and free from dust and the travel much more quiet and restful. I know the party from Marion missed us and I am certain many of them missed my oversight and my good advice and care of some of them.

They say Vancouver is a very beautiful city with a population of 175,000. We left the docks of the C. P. Co., about 10:00 o'clock and arrived in Seattle about 7 next morning. I went down to the dining room to get a cup of coffee before leaving the boat, but they wouldn't let me eat with the boat crew. The Steward said it was against the rules of the Company so I didn't argue with him about it. The Customs Inspector seemed to take right much interest in our baggage as we were landing at the wharf at Seattle, but all y bottles were of such a small capacity that he passed us with some apparent disgust.

I had sent a message to one of my brothers down in Tacoma to meet us at the Station, not knowing then that our tickets read by boat, so it was up to us to find a brother at the R. R. Station instead of boat landing and a brother too that I had not seen for 20 years, so immediately upon landing we took a yellow taxi, which, by the way seem to be like the poor, "ever with you" and crossed a part of Seattle to R. R. Station. About the first man I saw there was this brother looking for me. I said "hello Granville" in a big voice that made him turn about to see who knew his first name in Seattle. We introduced ourselves and his son took us and the family to a restaurant where we had our coffee from there he drove us over this splendid city and finally landed us at his home on a high elevation over-looking the city Reservoir.

Seattle is now the largest city in the State of Washington and is reached by the Canadian Pacific Steamers from Vancouver and Victoria with a direct night service from Vancouver and day service from Victoria. Distance from Vancouver to Seattle is 164 miles.

Seattle is a beautiful and a very progressive city and its population is on the rapid increase. The last census gave 315,000 but now it claims nearly 400,000. The city lies on Elliott Bay an arm of Puget Sound. This body of water runs inland more than 100 miles. The business section of the city is built on the coastal plain but the residence section is built on a series of hills and some of the hills are 500 ft. above the level of the bay. To the westward beyond the beautiful waters of the Sound can be seen the snow capped Olympic mountains, while on the eastern border of the city is Lake Washington 20 miles in length 3 miles wide. This Lake lies within the city limits and is connected with Sound by a canal with water deep enough for the largest ships. This city is called the "Gate Way to Alaska". There are lines to the Orient, Siberia, British Columbia and other ports. The down town section has many large buildings including one of 42 stories, the highest in America outside of N. Y. City. The University of Washington located here has 350 acres of beautiful grounds with immense buildings up-to-date in every respect and other buildings under construction. This city owns its own water works and hydroelectric power plants. Hydroelectric power on the Pacific coast especially in Seattle and Tacoma is cheaper than in any other cities in the U. S., I have been told. This is encouraging to manufacturing plants of all kinds. There are 44 parks embracing about sixteen hundred acres with many well kept auto roads. It is difficult for those of us who live on the eastern coast to realize the great distances of the west and western coast. For instance we might think Seattle is not any distance from San Francisco, but the truth is it is 953 miles to San Francisco and Vancouver.

## It's Time To Face The Facts!

With the election a month away, the constructive voters of this country should face the fact that while President Coolidge will certainly receive a large popular plurality, "spotted" political conditions create a serious danger that the election may be thrown into Congress unless there be the most active organized effort to overcome the destructive political forces of the country from now until the end of election day, November 4.

The La Follette Socialists do not expect the election of their candidates. They are trying and hoping for a deadlock in the electoral college which will defeat the popular will as expressed at the polls and enable the radicals by manipulation to elect a minority President. They will throw all their professed respect for popular decisions to the winds in that case, and substitute government by machination for government by the people.

The Democrats cause is hopeless. The only expectation of success entertained by the Democratic organization is that in case of no choice by the electoral college, either Davis in the House or Bryan in the Senate may be chosen President. To that end this organization is definitely encouraging the La Follette Socialists and planning to throw whatever Democratic support may be delivered to the La Follette Socialist ticket in doubtful states where there is no hope of straight Democratic success.

The result of a deadlock in the electoral college will be serious. It will plunge the country into four months of doubt and uncertainty as to the outcome of the election, and as to the character of the new administration. Business, which is slowly getting on its feet, would be prostrated by a no-decision election. Industrial depression and consequent widespread unemployment would be inevitable, because confidence and knowledge of the future is essential to sound business conditions, and both would be absent in the chaotic situation thus created.

It is especially important that Republicans in the states of Minnesota, North Dakota, South Dakota, Washington, Oregon, California, Colorado, New Jersey and the border states should be up and doing. The radical forces are preparing a huge October drive in these states, hoping thereby to defeat the will of the American people as they know it will be expressed in a big country-wide plurality for Coolidge and Dawes. In every congressional and senatorial district there should be the greatest activity, for the control of Congress as well as the Presidency is an objective of radicalism.

This nation has not faced a more important election since that of 1860. The perpetuity of our Constitution and form of government, definitely challenged by the La Follette Socialist forces, is at stake. No citizen has more important business, no matter what his other work may be, than that of going into the middle of the road with every resource at his command, to meet the menace of Socialism as presented in the candidacy of La Follette and Wheeler.



How much to the point the President's words are is shown by the fact that the government is taking \$6,000,000 a day less from the tax payers than it did when Mr. Harding became President. Actions speak louder than words.—Harrisburg (Pa.) Telegraph.

### THAT SCANDAL-LESS ADMINISTRATION

The National Republican has had occasion to refer to the enormous over-purchase of materials during the World War with the result that not only was the government loaded up with an enormous amount of surplus property for which there was no immediate or prospective use but prices of the materials from which these articles were made were boosted to unprecedented heights.

The Chicago Quartermaster Intermediate Dept., 1918 West Pershing Ave., Chicago, is offering at public auction on October 2, six years after the close of the war, one million pairs of cotton flannel mittens, 516 thousand pairs of cotton breeches, 440 thousand cotton coats, 112 thousand pickaxe handles, enough to equip four divisions of infantry, and much other property, the most of which was needlessly purchased during the war, when an administration "without scandal," as Candidate Davis says, was in power.

In Nebraska, according to late reports, President Coolidge and Charles G. Dawes will be winners with La Follette second and the Davis-Bryan ticket trailing in last place. Nebraska Democrats apparently believe about Davis everything said of him by Governor Bryan.

## DEMOCRATIC DEMAGOGUES MAKE

estimates running all the way from a million dollars a day to a million dollars a week as the cost to the American people of the failure of President Coolidge to reduce the tariff on raw sugar, as recommended by half the membership of the U. S. Tariff commission, 41 cents per hundred pounds. Assuming that the sugar refiners who are clamoring for this lowering of the tariff were to benevolently pass on their saving to the American people, which they could confidently be depended on not to do, such a reduction would benefit the average American consumer on his sugar consumption of 95.6 pounds per year, 39 cents per year, all of which would come out of the federal treasury through loss of customs revenue and be put on his back in direct taxes, whether the sugar importer pocketed the saving or passed it on to the consumer. At the same time the American beet sugar industry, which furnishes a market for 100,000 farmers and several thousand employes in beet sugar plants, would suffer serious injury.

John W. Davis' failure to win support in the western states he recently toured is sighted as proof that the Bryan brothers—Charley and W. J.—knew what they were talking about when they said "a Wall street lawyer such as Davis will not be popular in the West." The Bryan brothers predicted at the New York convention that if Davis should be nominated, the Democratic party would be doomed to another defeat and could not win an electoral vote either in the East or West. The Bryan brothers expressed that Davis, if nominated, would carry no states outside of the South. Davis' western trip was such a miserable failure, so far as making votes, that the Bryan brothers can say gleefully, "I told you so."

"The state of Illinois is Republican by 250,000 or more," writes Maurice Judd, political writer, to the New York Sun in a dispatch from Chicago.





## Withdraws From Race.

ABINGDON MAN QUITS FIELD IN INTEREST OF SO CALLED HARMONY IN NINTH DISTRICT

Richmond, Oct. 4.—Lou P. Summers of Abingdon today withdrew as Republican candidate for congress in the Ninth district. Accompanied by Joseph P. Brady, clerk of the United States district court here, he called at the office of the secretary of the commonwealth and filed formal notice of his withdrawal.

He withdrew in favor of C. Henry Harman of Tazewell who filed notice of candidacy today. Desire to further the best interests of his party prompted him to get out of the race, Mr. Summers said, and he verified the belief that Mr. Harman would be elected, despite the fact that he is practically an eleventh hour candidate.

Today was the last day for entrance of a candidate, the law providing that notices of candidates be filed not less than thirty days prior to the election which falls this year on November 4. Mr. Harman is Republican chairman for the Ninth district and has been active in the party councils for several years. He is identified with coal mining and other interests in the southwest and is reputed to be possessed of independent means. His Democratic opponent is George C. Peery of Tazewell who has been representing the Ninth district in congress for the past two years and is running to succeed himself.

This district was represented for many years by C. Bascom Slemph now private secretary to President Coolidge. Mr. Summers resigned the federal attorneyship for the western district of Virginia to enter the race for congress.

Recently Colonel J. W. McGavock of Wythe, another Republican leader in the district, brought about a split in the party ranks by filing charges accusing him of improper acts while district attorney. Entrance of Mr. Harman into the race is expected to heal this breach and restore harmony throughout the ranks.

Effort at Harmony, Bristol, Oct. 4.—An effort to heal the feeling engendered recently by charges made by J. W. McGavock, of Wythe county is seen by local observers in the withdrawal of L. P. Summers of Abingdon, as Republican nominee for congress in the 9th Virginia district.

Many leaders were convinced that campaign obstacles presented by the McGavock charges were more than Mr. Summers could surmount and it was reported that he had been advised by several heads of the district organization to retire.

Democratic district headquarters here tonight issued a statement in which Summers' withdrawal was characterized as "the complete collapse of the Republican congressional campaign in the district."

Summers Outlines His Reasons For Withdrawing  
Lewis P. Summers, who Saturday announced his withdrawal as the Republican nominee for Congress in the Ninth Virginia district, last night issued a statement in which he outlined his reasons for retiring as a candidate. Mr. Summers declared that he had not been influenced by charges recently brought against him but that financial reasons figured in his decision to withdraw.

Mr. Summers statement follows: "I accepted the nomination extended to me by the Republican party on February 4, when prospects of election were not bright. At that time I recognized the fact that my financial condition and the demands of my family were such as to cause me to question the wisdom of my accepting the nomination but my love of party and anxiety for its success prevailed, and for eight months I have waged the most aggressive and thorough fight in the district. In doing so I have embarrassed myself and friends financially to the breaking point. Feeling that I could not go further on this account I believed the interest of the party could be best served by my withdrawing from the race at this time. This conclusion was reached after deliberate consideration and I withdrew my candidacy over the protest of Mr. Slemph and my friends in the district.

"The recent charges made against me in no way influenced my action in this matter. Practically all the Republican leaders of the district assured me that these charges had strengthened me rather than weakened me in my fight in the district. "When I reached the decision to withdraw on Saturday, October 4, in Washington it was the last day a candidate could file the notice of candidacy with the Secretary of the Commonwealth. In a short time thereafter I met the Hon. C. Henry Harman who was in Washington attending the world series. The one man best fitted, in my judgment, to take up my work in this fight and win it and he agreed to file his candidacy rather than see the Republicans of this district be without a candidate. I hope that every Republican and all other men and women who believe in the policies of Calvin Coolidge will support young

Harmon. I wish to take this opportunity of expressing my affectionate regards to my friends in this district state for the loyal support they give me. My prayer is for a Republican victory in this district. Coolidge and Harmon."





## At Home and Abroad.

By Z. V. Sherrill

cover is nearly 1500 miles from Los Angeles.

We did not remain long in Seattle, but took the boat about 10:30 for Tacoma where we had expected to remain for at least a 24 hours with relatives. It is only 40 miles to Tacoma. We arrived there about 1 o'clock. Here we were introduced to another brother whom we had not seen for 35 years. Here we visited the Gregory Furniture Company's plant where they make furniture in an up-to-date factory.

We drove over the city in a Henry seeing the places of interest and visiting relatives. Next day we drove down to the Sound on a fishing trip. My nephew said it was not a favorable day at any rate it was not for us. The water was deep and the wind cool and the little boat with my 175 pound in one end of it persisted in sinking very deep into that cold clear water. Every time a large boat came within 100 feet or more and started the waves in our direction it gave me a most uncomfortable sensation, just if it might spill me into this deep water, and I am not very fond of water over four feet in depth any way. After about three hours experience with the fish we were glad enough to stand again on terra-firma.

From the Sound we drove over to one of the City's Parks, called Ft. Defiance Park, has 638 acres of original wood land and is regarded one of the finest in America. We passed through camping grounds with stoves ready for use by the public for picnics or camping.

Tacoma has a population of about 100,000, and is one of the great ports of Puget Sound, having a mile of wheat docks. It is on a peninsula between Commencement Bay and The Narrows.

Camp Lewis one of our largest Military Camps and is near Tacoma. Trade with the Eastern Countries from her docks is on the increase. Another place of interest is the Stadium at one of the greatest public school buildings in America.

The Stadium is built of concrete and seats 30,000 people. It was one of the stops of President Harding on his last trip where he made a public address. The climate is great—always mild, but unusually dry this summer. Irrigation is essential to growth, but the city has an abundant water supply and the lawns are kept beautiful. The fires in the Olympic Mountains and other ranges kept the air full of smoke and obstructed our view entirely of Mt. Rainier 46 miles away, elevation 14,408 feet, Tacoma is the gateway to Ranier National Park.

Along the Sound from Seattle to Tacoma is a wonderful trucking section all under irrigation. The Japs are engaged in this work principally and competition with these people is hard to withstand, but fine fruits, berries and vegetables are abundant and cheaper than on the Atlantic coast and dairy products are much the same prices that prevail here.

We left Tacoma on the evening of August 7th, with regret, to overtake our party at Portland, Ore. From Tacoma to Portland 144 miles. We passed through Olympia, the capital of the State of Washington a town of less than 10,000 and only 10 feet above sea-level, Centralia, Chehalis, Castle Rock, Kelso, Woodland, then Vancouver Washington, only 9 miles from Portland.

The Columbia River is a mile wide at this point. From this city to Astoria, the mouth of Columbia it is 100 miles. It is navigable for 2,136 miles has a drainage area of 259,000 square miles and might develop 19,740,000 horsepower. More salmon are caught and canned on this river than on any other in the world. Vancouver, Washington is an old town and founded in 1824 by Dr. John McLoughlin, a principal factor in the Hudson Bay Company. We crossed the Columbia here on the new Interstate bridge.

Next we come to Portland, a city of 258,389, but it is after night now and we have only one hour here having overtaken our party at Station. Other members of our party who had a full day in this city report a wonderful interesting day. We left Portland August 7th, at 9 P. M. over the Southern Pacific lines or to be more specific over the Shasta Route. Portland is 771 miles from San Francisco and is the northern terminus of the Southern Pacific.

We travel 150 miles through the Willamette Valley said to be a very productive country. Extensive peach orchards are to be found in this section of Ore. We are traveling now at night so can give little idea of Ore. Some of the principal towns along the route are Salem about 18,004 population, Albany, 5,000, Corvallis about 6,000, where the Oregon Agricultural College is located, 4,500 students, Lebanon known as "The Strawberry City," Eugene, population 10,500 where the University of Oregon is located with 2000 students. Several Southern Pacific branch lines center at Eugene. It is also the starting point for good fishing and hunting in the Cascade Mountains.

Cottage Grove, Roseburg, latter an important town and seat of Douglas County and R. R. Division of the "Shasta Route". Glendale is popular with fisherman and hunters, Grants Pass seat of Josephine County, situated on the Rogue River. From this point we enter the famous Rogue River Valley, containing in all about 1,000,000 acres between the Umpqua Divide on the northwest and the Siskiyous on the south Medford, population 5,756 where the valley is 12 miles wide. This is the fruit shipping center of Oregon. Here we bought some fine fruit along the way. Especially peaches.

Crater Lake National Park on the crest of the Cascade Range is about 80 miles from Medford. The Lake is 6000 feet above sea level and lies in the crater of an extinct volcano. This lake is six miles in diameter and is 2000 ft. deep with precipitous walls rising 1000 feet above the water. Crater Lake is recognized as one of the foremost natural sceneries of the world. Leaving Ashland Ore, we begin the ascent of the Siskiyou Mountains. The summit of these mountains is 17 miles from Ashland and we go up 2,235 feet to reach it. There is some very remarkable engineering work in efforts to overcome the grades. Three tracks can be seen one above another at one point. Near the top we go through a long tunnel and after emerging we come first in sight of the famous Shasta mountain.

Our next stop is in California, about which we have heard so much from school days to the present. While we have now entered the State of California we are yet more than 400 miles from San Francisco and 874 miles from Los Angeles. We traveled four hours of this journey within sight of Mount Shasta a peak snow-capped and 14,380 feet high. Night soon overtook us somewhere before arriving at Red Bluff, Cal., and we knew nothing further of this great country through which we were passing until we arrived at Oakland next morning about 7:30, 16th St. From 16th St. Station, Oakland, the line proceeds to Oakland Pier Station. The Pier extends a mile into the bay and has been filled in to almost its end.

This is the terminus of the Southern Pacific's Shasta and American Routes, North and East, which has the real terminus in the handsome Third St. Station, San Francisco. We crossed the bay on one of the ferry boats. The Southern Pacific however continues all the way to Los Angeles and also to New Orleans with slight change in part of the name, part of which is called the Sun-Set Route.
