Another Ship Sunk Unwarned.

New York, Sept. 20.—A torpedo sunk the British ship *Kelvinia* carrying 28 Americans, according to G. W. Dillard, of Richmond, Va., one of the Americans, who arrived at New York today on the Cunard liner *Tuscania*.

Dispatches from England left in doubt the question whether the *Kelvinia*, bound from Newport News, Va. to Glasgow, was torpedoed or sunk by a mine on September 2.

According to Dillard, the *Kelvinia* was torpedoed at 2 o'clock in the morning without any warning having been given. The vessel listed immediately and as there were not enough boats for both the crew and the Americans, who were engaged as hostlers for the cargo of horses, many of the Americans put on life belts and jumped overboard. They were rescued by a trawler after floating about fourteen hours.

Dillard said that at the time the *Kelvinia* met with the mishap he saw nearby a small light which later seemed to disappear under the waves. This, he declared, confirmed his belief that there had been a submarine at work.

He Ignored Bullets.

Pulaski, Va., September 16.—Refusing to leave the pulpit, when a number of shots were fired into the tent at Gunton Park, Wythe county where he was conducting services, the Rev. H. L. Trini, of the Holy Roller Church, calmly knelt in prayer while the congregation rushed in a panic into the open. Nine bullets were fired into the tent, which was filled with worshippers, as the minister was in the midst of the services.

"I'll stay and preach until God tells me to go," the minister said after vainly trying to calm the congregation. He directed his little grandson to go outside and find out what had caused the firing, and then went on with his prayer. It believed several young men who had been outspoken against the Holy Rollers fired the shots and escaped before the congregation got out of the tent. No one was hit.

Confederate Relic

Worcester, Mass., Sept. 16.—The presentation of a snare drum carried by the Thirteenth Virginia Regiment in the Civil War, to the Confederate Museum was the object of a trip to Richmond started today by the Worcester Continentals, a military organization of this city.

Several years ago the drum was bought by Dr. A. F. Wheeler from a local dealer who had obtained it from the son of a Union veteran. It had been found among the veteran's effects years after his death. Dr. Wheeler chose the Continentals as a medium through whom to restore the relic to the south. Poplarville, Miss., Sept. 20.—The Loyal Consolidated School, a two-story brick building, was partly wrecked by dynamite here last night and a large barn, the property of the school, burned. Bloodhounds were brought from Crystal Springs, Miss., but up to a late hour had failed to find a trail.

Grievances against the school is thought to have inspired the vandals. The Loyal School is one of the largest and best equipped consolidated schools in the state.

Raider Sighted In Atlantic.

Norfolk, Va., September 20.—Foreign ships arriving at Newport News for cargo and coal have reported to the British authorities that there is another German raider in the Atlantic. One of them reported sighting a mysterious vessel that started for and then changed her mind when she sighted smoke from what appeared to be a warship some distance away. They also reported that ships listed as lost by Lloyd's are believed to have fallen victims to this mysterious raider. British authorities decline to give any details as to where the supposed raider was seen and master of ships are not permitted to give out any information under penalty of losing their commands.

Badgering Hughes.

According to press reports Republican candidate for president, Mr. Charles E. Hughes was presented with a decided specimen of mob violence in Nashville, Tenn., last night. He tried to deliver a campaign address there but a roaring, riotous bunch of hoodlums interrupted and jeered and hectoring him to such an extent that speaking was a most difficult undertaking.

"Murderous Mary" Hanged.

Bristol, Va., Tenn., Sept.—Condemned to death by the state authorities, "Murderous Mary," the big female elephant, which killed her trainer several days ago, has been hanged at Erwin. A derrick car of the Carolina, Clinchfield & Ohio Railway was used. Heavy chains were looped about the elephant's neck, and the steam-operated crane lifted the massive form into the air. The animal struggled for a while before she died of strangulation. The showmen are said to have admitted that "Mary" had slain eight men, her last victim being Walter Eldridge, a Virginian, who was gored to death at Kingsport Tuesday. Showmen valued the animal at \$8,000.

Party of Women to Go With Hughes.

New York, Sept. 16.—Chairman Wilcox of the Republican national committee tonight announced the personnel of the women's campaign committee, the members of which will accompany the Hughes campaign train that will leave this city on October 4.

Entirely financed and managed by women, the train will carry as speech-makers, it was stated, women writers, orators and workers who are leaders in their fields of labor—Americanization, emigration, education, protection of women, probation, etc.

Among them are Mrs. Raymond Robins, Miss Mary Dreier, Miss Helen Lodd, Miss Francis Keller and Miss Maud Miners.

The train will tour twenty-eight States and will carry both suffragettes and antisuffrage women. Men will preside over the meetings.

UNITED STATES HONOR.

Hughes' Criticism of Foreign Policy Approved in West. (Portland, Ore., Telegram.)

The Republican party has selected a standard-bearer whose utterances from day to day justify the people who chose him. Not only does he bring before the country the shortcomings of the Administration that owes its existence to a divided Republicanism, but his criticism is everywhere constructive.

He tells what must be done and will be done by the party he represents to prevent wastefulness and extravagance in the governmental expenditures and to put a stop to the vacillating policy that has caused other nations to believe that the United States has no intention of backing up its demands made in the interests of justice and humanity.

Most vulnerable of all points in the Democratic armor is its foreign policy. Primarily this is because of the spoils system by which men trained in the consular and diplomatic service through long years, have been displaced to make room for politicians and friends of politicians, whose sole claim to preferment was their service to the Democratic party.

"If I am elected president of the United States," said Mr. Hughes last night, "I propose that every man I put in charge of an important department shall be a man eminently fit to discharge the duties of that department." The denuding of the diplomatic service of men of experience in order to supply political jobs, as has been done by Mr. Wilson, or with his consent, Mr. Hughes denounces as "a capital offense—trading in the good name of the United States and damaging its honor." "Nobody," he adds, "has a right to pay political debts with the good name and honor of the United States."

Which is clear proof that Mr. Hughes has not been unmindful of the high principles of government which must be maintained in order that this republic shall maintain its place as a shining example to all nations.

Andrews at Marion and Chilhowie.

Hughes-Slemp Club Organized.

The Republican campaign was opened in this County Wednesday when Hon. W. E. Andrews, of Hastings Nebr., spoke at Chilhowie at 3 o'clock and at Marion at 7:30 P. M. Rice a la Creole.

Chop a large onion, two seeded green peppers and half a cupful of raw ham. Mix well and fry lightly in butter. Add a cupful of parboiled rice, three cupfuls of beef stock, one cupful of stewed tomatoes and a teaspoonful of salt. Cook slowly until the rice is tender and the liquid nearly absorbed.

When Slicing Bacon.

Always place the rind side flat on the table when slicing bacon, and do not try to slice through it. When a sufficient number of pieces are cut slip the knife under them and you can easily slice them away very close to the rind.

Sewing Comfort.

When you sew on white goods, it is an excellent plan to keep a small saucer of flour at hand. Dip the finger tips in this now and then. The hands will not perspire and you will be able to handle the goods much more comfortably.

To Whip Condensed Milk.

Place one can of condensed milk in water and heat to boiling. Remove promptly and thoroughly chill by placing the can on ice. When cool, open the can and pour the milk, the entire contents of a small can or half the contents of a large one, into a chilled bowl, placed in another bowl filled with cracked ice. After the milk has become thoroughly chilled whip in the regular way with an ordinary egg beater for five minutes. Sweeten and flavor if desired. Keep it on ice until served. Condensed milk will whip without heating, but there are better results when following the above directions.

To THE HONORABLE P. W. CAMPBELL, JUDGE OF THE CIRCUIT COURT OF SMYTH COUNTY, VA.:

The undersigned, who are duly qualified electors and residents of Sugar Grove, Smyth County, Va. as an unincorporated town and thickly settled community, within this state, respectfully represent unto your Honor, that the good of the said community will be promoted by the incorporation of said community under the laws of state of Virginia, as enacted by the General Assembly of the State of Virginia, by an Act approved March 14, 1908, entitled "an act to provide for the incorporation by the Court of towns of more than Two Hundred, and inhabitants conferring upon said towns when incorporated, certain powers of taxation;" that the number of the inhabitants of the said community is 342; that number of inhabitants of said town exceeds Two Hundred, and does not exceed Five Thousand; and that the area of land designed to be embraced within the town, is not excessive that the meets and bounds of said town are as follows:

Starting at the Methodist church and as a center, run line due East one mile from church, then run line one mile due West from church and use said line for center line East and West, then take in one-half mile on each side of said centre line the whole length of it, making two square miles, or approximately 1,300 acres.

The prayer of this petition is that your Honor, will enter an order incorporating said town, by the name Sugar Grove, as provided for by the said law of the state of Virginia referred to above in this petition, with all the rights, powers and privileges of town so incorporated under said Statute.

British Casualties.

London, Sept. 8—Officers casual, lists for the last fortnight of August contain the names of 603 officers killed, 1,396 wounded and 93 missing, a total of 2,092. This brings the losses of officers in the British army since the commencement of hostilities to 41,014, of which 12,045 have been killed or died of wounds, 26,976 wounded and 2,893 missing. During the fortnight, Brigadier General Potter was wounded, Brigadier General Buckle killed and five lieutenant colonels killed.

Marion Health Conditions

For several weeks people in and around Marion have talked chiefly about sanitation and quarantine, and some of our friends have come to look on our town as little better than a "pest hole" when nothing could be farther from true.

In May the town water was examined and reports "good" by the State Health Board. Later just at the time all this excitement began another sample was sent by parties who did not know how clean a bottle must be when sending water for examination and this water was reported as having color bacilli in it. Another sample was sent in a clean bottle and the water was again reported "good" so this reason for a scare was removed.

There have been several cases of typhoid fever in town this summer, but no more than we usually have every summer. Today every physician in town has been personally asked how many cases of typhoid fever he had under treatment and I find there are now two cases in town and both of these are practically well for while they still take medicine the physicians are not in regular attendance.

The infantile paralysis cases are just as they have been for the past two weeks with no new cases developments of any kind.

The patients are reported to be improving as fast as could be expected and people quarantine regulations have been enforced by the town authorities, so no new cases need be expected. The danger from contagion has most probably been greatly exaggerated and some people have worked themselves into quite a needless excitement is daily becoming more apparent.

The general sanitary conditions in Marion are no worse than they have been. This is not saying they are as good as can be made. Our standards of a sanitary town have changed and we have not yet attained that perfection in things sanitary towards which we rightly aspire, but we can certainly measure up well with any other Virginia town.

Health Work In Sugar Grove.

Every one is taking an active part in the "Health Work" which is now in progress, and seeing that his or her place will meet the requirements of the "State Board of Health", and be listed as safe and sanitary. Typhoid fever, dysentery and intestinal parasites must seek shelter elsewhere and "Mr. Fly" will take up his abode in some other section of the county, for his birthplace will have been destroyed.

The few cents cost of sanitotia, as insurance against disease, is not considered when the mother and father thinks of their children's health; how they need the growth and development that sanitation holds in hand. The modern child is under such a strain to keep abreast with the trend of time, that it is of vital importance to conserve his nerve in

every possible way, in order that he may reach the goal with his fellow companions. At the expiration of one week, when the "Health Officer" will close, Sugar Grove will be considered a model for the county.



"I've had enough of it"

SEEK PROGRESSIVE AND LABOR VOTES ON FALSE CLAIMS

Democrats Posing as the Enactors of Legislation Which the Indisputable Facts Show to Be of Republican Origin.

AUTHORITY ON SOUND SOCIAL LAW CITES 11 GLARING CASES

Organized Labor Resents This Deception and Running True to Form Will in November as at Many Previous Elections Indignantly Smite Those Who Without Justice Lay Claim to Its Gratitude—Even the Much-Touted Federal Reserve Law is Based Entirely on the Statistical Research of a Republican Administration.

"That 'No class is more instant than labor to condemn and punish those who without foundation lay claim to its gratitude' is the assertion of John Williams, ex-commissioner of labor, apropos of certain false claims set forth by Vance McCormick, Democratic National Chairman, in behalf of his party.

Chairman McCormick caused to be published in the New York Times, on July 31, an appeal for Progressive and Labor support, based on 'twenty measures enacted by Congress while President Wilson has been in the White House,' and for which he claims credit for the Wilson administration and asks Progressive approbation. Commenting on this statement, the former Commissioner of Labor says:

"Students and promoters of sound social legislation will do well to examine this list for it contains a number of items of unusual interest. 'We may well believe that it was with a great deal of pride that Mr. McCormick contemplated the record of his party and that he drew a vivid mental picture of Progressives flocking to the support of Mr. Wilson because of the things claimed on behalf of this administration.

"It is a pity that in the interest of truth, which knows neither Democrat, Progressive nor Republican, we must mar this remarkable statement. Nevertheless, it is our duty to call attention to the fact that in his effort to induce support for Mr. Wilson the Chairman of the Democratic National Committee has fallen into a glaring error. We have no desire to disparage the achievements of the Wilson administration, but we must enter emphatic protest against any attempt to pad the Record.

"Mr. McCormick claims 'twenty measures enacted by Congress while President Wilson has been in the White House.' This claim we dispute. More than one-half are measures enacted under a Republican administration and were approved by ex-President Taft, and for others the Democratic administration deserves no credit.

"Let anyone think that this is a groundless assertion we herewith furnish the record which can easily be verified:

- From among the twenty pieces of legislation cited by Chairman McCormick, I select the following:
 - (1) Eight hour law on government work. In effect March 1, 1913. Signed by Mr. Taft.
 - (2) Eight hour provision for post office clerks. In effect generally August 24, 1912.
 - (3) Eight hour provision applicable to the manufacture of ordinance for the government. In effect January 1, 1913. Signed by Mr. Taft.
 - (4) Children's Bureau. In effect April 9, 1912. Signed by Mr. Taft.
 - (5) Industrial Commission Law to investigate industrial relations. In effect August 23, 1912. Signed by Mr. Taft.
 - (6) The phosphorous match law. Enacted in 1912, effective as to the importation of white phosphorous matches January 1, 1913, and as to the manufacture of such matches July 1, 1913. Signed by Mr. Taft.
 - (7) The Department of Labor Law creating a department with a secretary who shall be a member of the President's Cabinet. In effect March 4, 1913. Signed by Mr. Taft.
 - (8) The Parcel Post Law. In effect January 1, 1913. Signed by Mr. Taft.
 - (9) The Federal Reserve Law which, while passed during this administration, is based entirely on the vast work of investigation and compilation done by the Monetary Commission, during the Taft Administration, and closely follows, except in certain details, the legislation recommended by that commission.
 - (10) The eight-hour law for the District of Columbia, was fathered and put through by a Republican, Senator La Follette.

The anti-trust law antedates the Cleveland Administration—although President Cleveland never enforced it. From time to time, as with all great legislative acts, it has been necessary to amend or add to it, and the anti-trust law of the Wilson Administration was merely such an amendment, a logical development of the original act.

Mr. Wilson during the past few days has become such a life-long opponent of the pork barrel that he is almost sorry now he didn't veto some of those bills.

MEALS IN WARM WEATHER

Cold Dishes May Be Made Just as Appetizing as Hot Ones, and Are More Healthful.

If you arrange to have cold sliced meat three or four times a week, see that the rest of the meal is light. But on the days when you serve vegetable dishes as the principal part of the menu make sure that the rest of the meal provides sufficient nourishment to even up the menu and make it as a whole equal in value to a meat meal. For instance, you might have on Sunday, let us say, cold roast chicken with mashed potatoes, sliced cucumber salad and watermelon or berries. Monday night you might have a cold chicken jelly soup, made from the chicken carcass, a cold baked macaroni and cheese, with hot peas and potato chips, tomato with mayonnaise salad and a good, nourishing pudding with plenty of eggs and butter. Thus, in the chicken jelly, in the mayonnaise, made of eggs and plenty of olive oil, and in the pudding, you provide enough nutrition to make up for the difference in nutritive values of the meat and the macaroni dish.

Other good substitutes for meat dishes are rice souffle, spaghetti a l'italienne, cheese and rice baked, etc. You will find that almost every kind of salad will be welcome in the warm weather. When you make the salad dressings do not be sparing with the olive oil, for there is even more nourishment in real olive oil than there is in meat.

If you serve dainty cold meals and keep your table looking attractive, the hot weather will make very little difference in the appetite of your family.

To Cook Fresh Fruit. Cooked fruits are especially good for delicate appetites and digestion. Raw fruits are for those who are stronger and can get all the benefit from them; the benefit is diminished by cooking. The best way of cooking fruit is not by boiling, but by simmering. In cooking very tender fruit bring the sirup to the boiling point, then throw the fruit in the hot sirup, cover tight, remove from the range or fire, and let it stand for half an hour. This applies particularly to berries.

To prepare larger fruit, throw it in boiling sirup, cover tight and leave it five minutes on the range; remove and let it stand half an hour. One pound of sugar to one quart of water, or a pound to a pound, is the usual allowance for the sirup.



JUICE FROM FRUIT

HOT-WEATHER DRINKS AND COLD-WEATHER JELLIES.

Member of the Faculty of the Missouri College of Agriculture Tells of the Best Methods of Collecting the Juices.

The hot weather led Miss Addie D. Root of the Missouri College of Agriculture to urge the members of the girls' canning clubs all over the state to can as much fruit and vegetables as possible before it is too late. It is one of the principles of these clubs, organized and directed by the college, to see that nothing is wasted if they can make good use of it. In her recent letter of directions to the girls Miss Root makes many suggestions that are just as applicable in the kitchens of grown-ups as anywhere else. She says: "Canning-club members may vary the work by canning fruit juices. They are a valuable addition to the canning collection, as they can be used in so many ways. There is a great advantage in preparing them in large quantities to be used throughout the year.

"The juice may be extracted from the fruit cold by crushing the fruit in a fruit press or a cider mill or a small press after it is washed and sorted. The most economical method for the extraction of juice is to cook it out.

"If juicy fruits, such as currants, raspberries and grapes, are being used, place the clean fruit in an enameled preserving kettle, add just enough water to prevent burning (one cupful to four or five quarts of fruit). Place where fruit will cook rather slowly, stirring occasionally with a wooden or enameled spoon. When the simmering point is reached mash the fruit, then continue heating until the whole mass is cooked through. Care should be taken not to heat too long, as the delicate flavor is destroyed. Pour the hot mass into a sufficiently large piece of coarse cloth, cheesecloth or flour sack, which has been wrung out of hot water. Tie the opposite corners together and let juice drain into an earthenware or enameled dish. If a clear juice is desired, as for jelly, do not squeeze the bag. However, for general use squeeze the bag until all the juice is extracted. From less juicy fruits, like apples, pears and quinces, wash the fruit, discard any unsound portions, cut into small pieces (skins and seeds included), cover with water, then proceed just as in case of juicy fruits.
