VIRGINIA:—At a meeting of the Board of Supervisors of Smyth County, at the court-house thereof, on Monday the 2nd day of November, 1925—

Present: J. A. Eller, Chairman, S. W. Keesling and W. W. Buchanan. A. M. Newman, Game Warden, presented a petition, signed by more than 100 land owners and holders of hunting licenses, asking for the shortening of the open season for hunting partridges, and upon motion the following ordinance was adopted:

"Be it ordained by the Board of Supervisors of Smyth County that, pursuant to the provisions of Section 3356, of the Code of Virginia, it shall be unlawful for any person to hunt, kill or capture partridges (quail) in Smyth County, between December 31, 1925 and November 15, 1926."

And it is ordered that the foregoing ordinance be published for two weeks in the Marion News, a newspaper published in Smyth County.

PARENT-TEACHERS' ASSOCIATION ORGANIZED.

Quite a large number of the citizens of Marion assembled in the auditorium of the Marion Grammar School Friday afternoon for the purpose of organizing a Parent-Teachers Association, having for their object the desire to co-operate with all of the school officials and to aid the schools of Marion. Special plans were developed for a permanent organization were launched. Mr. John Nye, of Saltville, who has charge of leagues in this county delivered a short talk upon the method of organizing and what the league had done for various communities. Mr. Nye, was preceded by Mr. W. R. D. Moncure, of Marion, who is a member of the Marion School Board and who has the interest of all public enterprises at heart, which work for the advancement of schools. Mr. Moncure made a very stirring appeal for an organization which would mean something to the children and to the schools. Mr. Moncure has always supported any school interests anywhere in this section and he made a very vivid description of the value and importance of community organization.

Mr. W. L. Allen, Principal of the Marion High School, acted as Temporary Chairman, and at the conclusion of the speeches made a few remarks expressing the desire of the people in general and the willingness of the Faculty of the Marion School to aid any organization organized in Marion, and then appointed a Nominating Committee composed of Mrs. J. P. Sheffey, Mrs. C. A. Pruner and Mrs. H. P. Gills, who retired to an adjoining room and prepared a ticket which met with the unanimous approval of all present.

The following officers were elected: Mr. H. T. Lawford, President, Mrs. W. W. Hawkins, Vice-President, Mrs. Glenn P. Anderson, Secretary, Mrs. A. L. Cox, Corresponding Secretary, and Rev. G. A. Wilson, Jr., Treasurer. Another meeting will be held about the middle of November at which time it is hoped that some of the State Officers of the Association will be present.

THE ELECTION

The election for the choosing of State officers for Virginia has come and gone, and the people have selected the men that will control the affairs of the State for the next four years. From the returns it is known that Mr. Harry Byrd of Winchester, the nominee of the Democratic party, has been elected by one of the biggest majorities that has ever been given a candidate for the high office of Governor. Mr. Byrd's election by such a large majority is no doubt due largely to the position that he occupied when the question of bonding the State for the building of roads was before the people. He was squarely and out-spokenly against any bonding of the State claiming that the taxes were as high as the people could stand, and the result of the bond election clearly proved that the voters of the State thought as he thought on the question of higher taxes. He went before the people in the election for Governor on the same platform that he took in the bond issue question, and has made the people the promise of an administration of the State affairs economically, and a reduction of the expenses of the State government. The people have believed in his promises—now it remains to be seen if he will make those promises good to the people of Virginia.

Mr. Byrd has got a hard road to travel if he abides by his pre-election pledges. His predecessor, Mr. Trinkle, went into office with every promise to the people of a reform of the abuses in the government of the State, (which are so pronounced that the Democrats themselves acknowledge them) how he has made good his pre-election pledges during the past four years is a matter of history. Much the same conditions exist today as existed when Governor Trinkle went into office—and where are the promised reforms. Forty thousand office-holders must be provided with fat jobs, and the tax-payers will have to pay for the jobs. Will Governor-elect Byrd break away from the office holders ring that has the State by the throat? If he does he but seals his political doom as far as the Democratic party of Virginia is concerned.

The future looks dark for the poor tax-payer of Virginia. As he scans his tax ticket this year he has but small promise that it will be any lower in the next four years. Just so long as the Democratic political ring has control of the destinies of Virginia just so long will the tax-payer have to pay for its up-keep and provide good fat jobs for the machine politician. But there is one bright spot at least to be seen in the Tuesday election. Loyal old Smyth County has been true to the faith of the fathers confided to their keeping, and sent to the Virginia Legislature a true and loyal son, that has proved his truth and faithfulness in the past, and can be depended on to stand true and faithful to his people in every emergency in the future. George F. Pierce has been re-elected by an increased majority, and will as faithfully represent his people in the future as he has in the past.

PROCLAMATION ON ROLL CALL OF AMERICAN NATIONAL RED CROSS.

Whereas the Ninth Annual Roll Call of The American National Red Cross will be conducted from Armistice Day to Thanksgiving Day, November 11th, to 26th, and,

Whereas, the above period is the time set aside during which every American everywhere will be invited to enroll or to renew membership in the organization, and,

Whereas, the President of the United States, as President of the American Red Cross, has issued a proclamation, calling upon the people in support of this humanitarian effort, and,

Whereas, no nobler theme could engage the consideration and active approval of our men and women,

Therefore, I, E. Lee Trinkle, Governor of Virginia, do hereby very earnestly call upon the whole citizenry of the State to support in all and in every appropriate manner the splendid work of that noble band which, during time of stress and peril in the hospitals and on the battlefields of France served God and man by ministrations to the wounded and through alleviation of pain. And I suggest that both men and religious orders and organizations take active part during the period of time indicated in support of the American National Red Cross.

Given under my hand and under the Lesser Seal of the Commonwealth of Virginia, this thirtieth day of October, in the year of our Lord one thousand nine hundred and twenty-five, at the city of Marion, in the one hundred and fiftieth year of the Commonwealth of Virginia.

Big Business In Fifth District

Richmond, Oct. 30.—With the exception of certain portions of North and South Carolina, business in the fifth federal reserve district is continuing in large volume, with indications pointing to a further expansion, according to the monthly review of business and agricultural conditions in the district, announced today.

Agriculture Remunerative.
The long drought and excessive heat of the past summer caused virtual crop failures, but on the whole agriculture has probably been more remunerative this year than in 1924, says the report. The sections perhaps hardest hit were the Piedmont counties of South Carolina, and sections of North Carolina, where the adverse conditions were especially felt.

Cotton production in the fifth district was in excess of the 1924 production, and the tobacco crops of both the Carolinas were considerably larger than last year. Maryland farmers are reported to have enjoyed a successful season.

Building Increasing.
Building construction, on which business activity for the past several years has depended largely, continues at an unusually high level. The number of permits for new work issued in September exceeded the number in August, despite the seasonal tendency to decrease at the approach of cold weather.

Labor is nearly fully employed, assuring a high purchasing power among urban dwellers. Debts to individual accounts at clearing house banks are about 14 per cent in excess of the 1924 figure, indicating the existence of a heavy volume of general activity in business.

Retail Trade Better.
The retail trade, while slightly less in volume of September, 1924, was far in excess of August trade, and also was larger than the trade in September, 1923. Wholesale trade is in seasonal volume, and collections are improved over the past several months.

Due to the high rate of production of soft coal in the fifth district, West Virginia prospects for fall trade are better than they have been for the past several years.

To Make Highways Safe For Travel.

Washington, Oct. 30.—Assistant Secretary of the Treasury Andrews today took steps to make the highways safe for tourists and incidentally for those who carry a small flask of liquor in their automobiles.

Orders were issued to regional prohibition administrators to concentrate on "big game" and not make the federal law "obnoxious and cheap" by halting automobiles and by arresting minor offenders.

Andrews cited as an object lesson his action in approving the dismissal of a New Orleans agent who arrested a man and a woman after finding a small flask of whiskey and a bottle of cordial in their automobile. The agent forced his prisoners to travel 168 miles, under arrest, to New Orleans.

"It is inconceivable to any thinking person that federal agents should be spending time and money on such work as this when there are so many cases of serious law violations to be handled."

"I again urge the importance of concentrating our energy upon closing the sources of supply and punishing the big violators and others who are profiting by traffic in liquor."

This powerful ultimatum curbs ambitious agents from embarrassing minor offenders and permits virtually the "winking" at hip flask toters, instead of subjecting them to arrest.

Andrews now has his reorganized prohibition force 50 per cent complete. All "key" positions are filled and only a few agent appointments are hanging fire.

Natural Bridge Is To Be Sold.

Richmond, Va.—Natural Bridge, one of the most famous wonders in America, will be bought by a group of Virginia business men, principally of Richmond, and headed by Oliver J. Sands, James J. Pollard, George M. Crump, Raphael Levy and J. Lee Davis, if negotiations in progress for some time are successful, it is announced by Mr. Sands.

An option is held by the group and the deal is expected to go through within a fortnight or so, Mr. Sands said. The purchase price is in the neighborhood of \$500,000, and the property to be conveyed consists of the bridge, a large hotel and an acreage.

In addition to the Richmond men named, several others of Staunton and Lynchburg are interested. The new company, according to Mr. Sands will modernize and improve the property and make of it one of the most beautiful spots in the country. The plans, now under way, call for extensive alterations and additions which, Mr. Sands said, would make it still more a Mecca for tourists and vacationists than ever before.

The deed to the property, dating back to its conveyance to Thomas Jefferson on July 5, 1774, is being examined by attorneys for the new purchasers and surveyors are now at work plotting the grounds for the papers.

The property is now owned by the Natural Bridge Company. It is near a small village that bears its name and is 179 miles by rail from Richmond. The bridge is a natural limestone strata 90 feet long by from 50 to 150 feet wide and 215 feet above Cedar Creek, which runs beneath it. It was part of an old cave and is now part of a public highway. It is in Rockbridge County and was held by Thomas Jefferson until 1833.

The present sale had its inception with negotiations of George M. Crump early in August, which were reported in The Times-Dispatch. The Richmond purchasers later conceived the idea of forming the company and making the property a real asset to the State.

MORE TAXES WILL BE PAID BY LIGHT AND POWER FIRMS

Richmond, Oct. 24.—Light, heat and power companies in Virginia will pay into the State treasury this year a total tax of \$210,090, or \$15,285 more than last year, according to an announcement today from the State Corporation Commission.

Real and tangible personal property, except money held by these companies amounts to \$24,557,168, an increase of \$3,152,921; money totals, \$1,171,776, an increase of \$207,478; and gross earnings and receipts are

\$17,246,549, or \$849,423 more than last year.

Taxes paid by the State by all public utility corporations this year will amount to approximately \$275,000 more than in 1924. Only the car-loading companies remain to be assessed for the 1925 payments.

MILLION BAPTISMS HAD BY BAPTISTS

New Evangelistic Record for Nation for Five Years Set Up in South.

WOULD DEVELOP MEMBERS

Effort to Enlist Entire Constituency of 3,500,000 in Regular Giving Planned Soon.

More than one million new members have been received into the Baptist churches of the South by baptism alone during the past five years, according to a survey by Dr. E. P. Alldredge, statistical secretary of the Southern Baptist Convention. The exact figures, 1,037,550 baptisms,

set a new record not only for Southern Baptists, but for any evangelistic body in America, the records reveal. This achievement is equivalent to 24 baptisms for every hour, 576 for every day, 8,990 per week, 17,292 per month and 207,510 per year.

Prominent in the achievement of this result has been the Home Mission Board of the Southern Baptist Convention, with headquarters in Atlanta, Ga. This board, organized eighty years ago has, within that time, more than a million baptisms and 1,428,386 additions to the churches to show for the labors of its missionaries, while the agents of the board have within that period raised and disbursed in mission work in the South, Panama and Cuba the sum of \$18,213,336.10.

Last 22 Years Productive
The larger part of these achievements of the Home Board has come during the past 22 years, covering the secretaryship of Dr. B. D. Gray. Under Dr. Gray's administration the workers of the board have baptized 662,497 persons, received 1,122,344 persons into the churches and organized 4,997 new churches. Within the same period the agents of the board have raised and disbursed in mission work the sum of \$14,723,595.87.

The evangelistic department of the Home Mission Board has been its greatest single evangelistic asset. This department has been without an active head recently, but the board has just called to that position Dr. Ellis A. Fuller of Greenville, S. C., and he entered upon his work October 1. He is a young man of college and seminary training and has been unusually successful in soul winning and other phases of work as a pastor.

Southern Baptists have been far more successful in winning converts and church members than they have been in the general spiritual development of the members, it is pointed out. In the hope of bringing about a development of the 3,574,531 members of the denomination to the point where all of them will have a share in supporting all the missionary, educational and benevolent work fostered by the denomination, an Every Member Canvass will be conducted in a majority of the 27,000 Baptist churches throughout the South, during the late fall and winter, the majority of the states employing the week of Dec. 6-13.

Would Enlist Every Member
The canvass will be conducted under the general auspices of the Co-operative Program, which is fostering state, home and foreign missions, the Baptist schools, hospitals and orphanages, and the work of ministerial relief. The ideal toward which the commission is striving is that of every member, giving every week to every cause in proportion to his ability, through his local church. As fully as possible individual Baptists are being urged to give a tenth of their income to Christian work.

So extensively have the various missionary and benevolent enterprises fostered by Southern Baptists grown in recent years that it now requires a minimum of \$13,000,000 per year to keep the work growing. Each state is being asked to provide its proportionate share of this amount. The state boards, in turn, are asking the respective associations in their states to accept definite quotas for 1925, and the associations, in turn, are asking the local churches to assume a definite proportion of the associational objective for the year.

Several of the members of the Marion Kiwanis Club, motored to Pulaski, Monday where they attended a meeting of several clubs for the purpose of uniting their efforts for the advancement and more rapid development of Southwest Virginia. This was a great meeting and it is one of the chief methods of cementing more firmly that spirit of co-operation which is rapidly developing in the communities of this section.

"Spec Swindlers"

Norfolk, Va.
Editor Post-Herald,
Dear Sir:
During the eight years that the Optometry Law has been in effect in Virginia the old time "spec swindler" has almost disappeared. Under the optometry law every person fitting glasses to the eyes must obtain a license from the State Board of Optometry (unless he has a medical license) exactly like the dentist, pharmacist, etc.

Occasionally, however, the rural districts are visited by the eye-glass bootlegger, with his wonderful "half price" eye-glass bargains, "medicated glasses," etc., often using newspaper space, (and often not paying for it) leaving a trail of ruined eyes, depending on his nimbleness and an assortment of allases to keep out of the clutches of the law. The public should look with suspicion on any person offering to fit them with glasses who cannot produce a license from the State Board.

Knowing that the press can do more than any one power to protect the public from the swindler who preys on its eyesight as well as its pocket book, the State Board of Optometry feels that any publicity you may give this subject will be a real service to your readers.

And—sheriffs, constables and readers alike may be interested in the fact that a reward of \$25 will be paid any one causing the arrest and conviction of any violator of the Optometry Law.

HEALTH WORK REDUCES DEATH RATE IN STATE

Richmond, Oct. 30.—Progress made by the health authorities of Virginia in reducing the death rate of the Old Dominion was praised by Dr. Frederick L. Hoffman, statistician for the Prudential Life Insurance Company, yesterday before the South governors' conference, according to an Associated Press dispatch from that city.

"Dr. Hoffman discussed in detail the continual effort to reduce deaths from yellow fever, typhoid, malaria and hookworm," said the dispatch. "He emphasized particularly the progress made by the authorities of Virginia, which state, he declared, has as normal a death rate as any one of the leading states. He attributed the forward results in Virginia largely to the cooperative county health work, in which local authorities are assisted by state and federal experts."

VIRGINIA LUMBER PRODUCTION OFF

Richmond Nov. 2.—Virginia's production of lumber declined 9.7 per cent during 1924, as compared with the previous year, a report by the United States Department of Commerce shows. The production for 1924 was 696,054 thousand feet as compared with 770,771 thousand feet for 1923.

Sawmills Inactive.
The number of active sawmills declined from 971 in 1923 to 954 in 1924. The figures do not include sawmills cutting less than 50,000 feet.

North Carolina also saw a decrease in lumber production, the production falling 2.2 per cent in 1924 over 1923. There were 1,095,925 thousand feet cut during 1923 as compared with 1,071,912 thousand feet during 1924. The number of active sawmills, however, increased from 1,084 to 1,120 in 1924.

Figures of Production.
The figures of production include lumber, lath and shingles. The figures for whole United States showed a decrease in 1924 over 1923 of 3.3 per cent. Of twenty-nine States that reported the production of more than 150,000,000 feet of lumber in 1924, nineteen showed a smaller cut than for 1923. The decrease was shared by all producing regions of the United States.



Boys Win on Baby Beeves

SMYTH COUNTY CLUB BOYS AGAIN SUCCESSFUL

Calves Fed by Juniors Make Excellent Showing at Three Fairs.

The splendid showing made by members of the Smyth County Baby Beef Club, at the State, for the past several years, is common knowledge among competitive exhibitors. Again this year they and girls were most successful, being rewarded for their efforts, with a high general average, both as to premium won and prices received for animals sold.

Not the least of the value of Club Work as it has been conducted in Smyth County is the training and experience gained by the members. Thru this work, able and efficient livestock men are in the making and future years may be approached with the confident belief that in the youngsters now at their daily tasks on the farm, the highest type of citizenship will be revealed.

Faithfulness to duty, day by day, accuracy and neatness in records kept and a spirit of friendly rivalry constitute some of the things necessary to success in this work.

The boys and girls in Smyth County started with a total live weight of 5782-lbs and finished the three hundred day feeding period with a

total live weight of 12065-lbs, showing an average gain on twelve animals of 524-lbs while the greatest gain was made by Jno. Fry Cole on his Hereford steer, which put on 611 lbs.

The average cost of all animals used was \$124.50 including feed and labor, and the average selling price was \$162.49, making an average profit of \$37.99.

The above figures do not include prizes won. These also represent a neat little sum added to the Bank account of each member, for Club members have accounts of their own with the Bank.

Total prizes won by the Club amounts to more than seven hundred dollars.

Outstanding individually, so far as premiums and honors won are concerned, was the Hereford steer exhibited by Robert Anderson. Roberts' calf was the Grand Champion Baby Beef at the Smyth County Fair and again at the Roanoke Fair. At the Virginia State Fair, this calf was second prize Hereford. Other members showing excellent calves and their placings at the State Fair were as follows: Richard Duncan, second prize Shorthorn, Clay Eller, third prize Angus, Evelyn Eller, fourth prize Shorthorn, Jno. Fry Cole, eighth prize Hereford. In the group class of five calves from one County, Smyth was second.

That the Smyth County Club reached a high general average this year may be seen from the fact that only one calf was shown out of the money in Richmond and all were sold at top prices, which ranged from 15% to 16% cents.
